#### THE DEAF HEAR AND THE DUMB SPEAK

Jesus made the deaf hear and the dumb speak. We need God to touch our ears in order to be able to hear his word, and we need God to touch our tongues in order to be able to profess our faith.

Jesus performed this miracle in Gentile territory. The faith response of the Gentiles contrasts sharply with that of many of his own people. In Mark's mind, Jesus was fulfilling the prophecy of Isaiah – "the ears of the deaf will be unsealed, and the tongues of the dumb sing for joy (First reading). Yet James in the Second reading today warn us, that we must treat everyone equally, because we are brothers and sisters. In the time of our baptism, we are called children of God. In other words, Jesus is the one who brings salvation to Israel.

The miracle is the only cure in the Gospel of Mark this Sunday, which is described as taking place gradually. Mark saw it as an illustration of growth in faith. It is what happens to every Christian at baptism. Christ touches our ears so that we can hear his words and touches our tongues so that we can profess our faith. Hence, we too can say "He has done all

things well. He makes the deaf hear and the dumb speak." May Jesus Christ touch our tongues that we may go out and proclaim the good news of God's kingdom to our parish of Stella Maris and to our Diocese of Christchurch.

# Parish Property Consultation – Property for the Future 31<sup>st</sup> August/1<sup>st</sup> September 2024

#### Introduction

As indicated in recent Mass announcements the Parish Leadership Team is preparing to consider building and property related issues across the whole of Stella Maris Parish. For consideration of these matters Bishop Michael encourages that

- Any new buildings or projects that we undertake should be centred on prayer
- During our planning and decision-making processes we should prioritise resources for mission rather than just buildings
- Overall, our call is to prioritise evangelisation and the development of our faith community

Bishop Michael has also emphasised the need for consultation with parishioners on all property matters as they work to define their future property needs. This newsletter is the beginning of that work.

#### The Stella Maris Parish Property Situation

In Stella Maris our many properties come under a number of categories

Active churches and Mass centres at Woolston, New Brighton, and Sumner

**Note:** St Andrews Church in Diamond Harbour is also an active Mass centre, though it is owned by the community, not the Parish. A hire fee is paid

Sites of previous churches and presbyteries, some now bare land, others with buildings still on, some of which are rented out

Residential and other properties rented out

We need to decide which properties we want to retain, in present or revised condition; and what to do with the others. We also need to consider whether we want to acquire other property.

#### The Stella Maris Parish Financial Situation

Our Parish is a combination of several smaller predecessors which have brought together a raft of people, histories, personalities, property assets, and financial positions. In our new configuration of Parish, we wish to emphasise that "We Are One". A number of property projects have been undertaken since the earthquakes. To the extent that the combined cash reserves of the previous parishes have not been sufficient, these projects have been funded by the Diocese. The expectation and the requirement are that the Parish will repay this amount in due course; which in current language means as soon as possible; and before other major property projects are undertaken within the parish. That is the first challenging reality.

Within Stella Maris Parish this debt to the Diocese is \$1,397,508 as at April 2024. This debt arises from:

- 1. Development work undertaken in Lyttleton, including the subdivision of land, work on retaining walls, land remedials, and preparation of property titles for possible sale. This included creation of the pocket of land for establishment of the permanent memorial to the significant former St Joseph the Worker Church and Parish.
- 2. Aranui Presbytery ground and general improvements prior to Healthy Homes upgrade, and subdivision work in preparation for eventual sale.
- 3. St Marys New Brighton church development debt remaining balance.

While the above paragraphs deal briefly with the capital funding situation, we must remain aware of operational funding. Parishioners have recently been advised of operational finances in Fr Job's update provided with Planned Giving receipts. This was also available on request from the Parish offices, as advertised in our Parish newsletter. The reality is that the Parish is running at a deficit; this is a chronic situation that must be corrected. The other reality is that a useful amount of parish income is derived from property rental. This simply means that if the parish sells property that is rented out the income of the parish will go down, the operating deficit will increase. That is another challenge to be overcome.

The responsibility to provide both capital and operational funds rests with the Parish, not with the Diocese.

#### Our Properties and What Might be Done with Them

#### 1. Those for which no change or consultation is envisaged within the foreseeable future

- New Brighton-St Mary's Church
- Woolston: The houses at 729 Ferry Road, one publicly rented house (upgraded to Healthy Homes standard) and Fr Paulo's Pad, parish office at 733 Ferry Road, Sister's house at 733A Ferry Road.
- Lyttleton: 14 and 16 Exeter Street Lyttleton; site of the former primary school, now rented out commercially to Busy C's pre-school; produces good rental income.

#### 2. Those for which change, or attention must be considered subject to more research

Church, former presbytery and school property at Sumner

In February 2023 the Diocesan property team and Catholic Education Office supported a proposal developed by the Parish and School BOT for future use of the school and church property. Briefly this involved a limited land swap between parish and school entities, a repurposing of some Parish property, and the release of subdivisible land for the benefit of the Parish. Consideration of this proposal was put on hold due to the Canonical Challenge and must now be re-activated, involving both parishioners and the school community.

St Annes Church and associated buildings

The precinct of St Anne's Church is established as the central point of Stella Maris Parish. As such there is an expectation of having at the site a main Parish church, a decent parish centre and administration facilities, and suitable accommodation for a number of priests. In addition to the adjacent St Anne's Primary School and the houses mentioned above, the properties here are:

St Annes Hall – 739 Ferry Road The presbytery – 739 Ferry Road The church of St Anne's – 739 Ferry Road The church is the major item here. Following earthquake damage some repair and strengthening work was carried out. This was sufficient to allow the church to be reoccupied, albeit with some limit on numbers. While the building is not earthquake prone it is at a lower level of structural strength compared to New Building Standard than is typically aimed at in refurbishment projects.

In addition to structure there are other issues to be considered e.g. – chronic heating and lighting issues, the condition of the roof and various architectural features. Current investigation work aims to have reached a good understanding "in broad terms" of the building and its issues, along with improvement/refurbishment opportunities, within two months. Consultation in regard to this precinct should in due course also cover other facilities that have been mentioned over the years, e.g. a fit for purpose parish centre and office facilities.

## 3. Those for which change must be considered and for which reasonable information is already to hand, or is imminent.

These are properties for which sale is the key option to consider. Typically, they are vacant producing no income, or occupied and producing low income. The last page provides some idea of possible values.

- 18 Winchester Street, Lyttleton the vacant site of the former St Joseph the Worker Church
- 21 Exeter Street, Lyttleton the former presbytery; house still remains, though not up to Healthy Homes standard

**Note regarding** the Lyttleton properties. – prior to the Canonical Challenge these properties were already approved by the Bishop for sale so strictly speaking consultation is not required. Nevertheless, they are being included for the sake of completeness of information and consideration.

1 Carisbrooke St together with 12 Sandown Crescent, Aranui – the site of the former Aranui church
and presbytery. The deconsecrated former church is rented out as a hall, while the house upgraded
to Healthy Homes standard is rented out. This large property is on one title, with frontages onto two
streets

**Note regarding** the Aranui property – as with Lyttleton this property was previously approved for sale by the Bishop, and nevertheless is still being included within current consultation. On the one hand there is no pressing need to sell this property as it is producing income. However there has been an approach from a prospective buyer, hence sale is at least topical. The sale option can be reviewed in due course based on economic considerations.

 118 Lonsdale Street, New Brighton. Adjacent to St Mary's Church. A standard residential sized property, occupied by a highly modified former house, previously rented out to Ferndale School, currently vacant.

#### **Consultation Process in More Detail**

Following the issue of this newsletter detailed consultation, with invitations to provide feedback or attend meetings as appropriate, will begin within four weeks. Updates and invitations will be provided regularly via the parish newsletter and website. An important point to make is that regardless of which property is being considered the invitation to be involved in consultation is available to all parishioners in our Parish.

In the meantime, in order to help the planning of the consultation detail, it would be helpful if the Committee could get a feeling for how many people are interested in taking part in consultation events, e.g. meetings.

To this end you are encouraged to <u>email the parish office and register your interest</u>, indicating whether this is a general interest, or whether your interest relates to something specific (please say which).

#### **Early Numbers**

Formal market appraisals or registered valuations have yet to be completed for possible sales, and formal estimates have yet to be sought for possible projects. Nevertheless figures have been "quoted" in the past by people of some knowledge in these areas. Because some people like to have numbers these are tentatively repeated in the schedules below to help parishioners understand the size of the issues. Note that GST may be payable on some sales.

#### Possible Sales, less sale costs and fees

Lyttleton: 18 Winchester St - \$600,000 approx.

Lyttleton: 21 Exeter St - \$600,000 approx

Aranui: 1 Carisbrooke St (Church) and 3 Carisbrook St (House) - \$700,000 approx.

New Brighton: 118 Lonsdale St - \$500,000 approx.

Sumner: 45 Colenso St - \$1,700,000

#### Possible Projects, estimated costs exclude GST, all approximate

Pay off debt to Diocese - \$1,400,000

Projects associated with any school remodelling - \$1,000,000

St Anne's Church, structural upgrade to 67%NBS - \$2,750,000

St Anne's Church, architectural refurbishment - \$1,000,000

Other works on St Anne's church precinct, parish centre, offices, fit for purpose presbytery etc– not assessed, but could be up to say another \$2,000,000 depending upon scale; hall not included in these figures.
